*For the purpose of this Permit and the terms and conditions specified below, the following definitions apply:*

**1. DEFINITIONS**

- (a) "Ministry" means the Ontario Ministry of the Environment, Conservation and Parks.
- (b) "Pesticide" means the pest control products and associated Pest Control Products Act No. specified in this Permit
- (c) "Director" means any Ministry employee appointed by the Minister under *Section 3(1) of the Pesticides Act*.

- (d) "Permit" means this *Perform A Water Extermination* permit issued in accordance with *Section 7 of the Pesticides Act*.
- (e) "PCP No." means the Pest Control Products Act number.
- (f) "Size of Treatment Area" means the approximate surface area of the water body to which the application of the pesticide under this Permit is authorized.
- (g) "Maximum Application Rate" means the maximum label rate at which the pesticide may be applied to the water body.
- (h) "Amount of Pesticide to be applied" means the maximum amount of pesticide that is authorized to be used pursuant to this Permit.
- (i) "Treatments authorized" means the maximum number of treatments authorized by this Permit.
- (j) "Treatment Period" means the period of time during which this Permit authorizes the application of the specified pesticide to water, in conjunction with the conditions set forth in section 3 of this Permit.
- (k) "Provincial Officer" means any person designated in writing by the Minister as a Provincial Officer pursuant to *Section 17 of the Pesticides Act*.

*The Permit Holder is only authorized under this Permit to perform the extermination using the Pesticide and in accordance with the terms and conditions specified below:*

### **3. CONDITIONS**

- 3.1 The Permit Holder shall perform the extermination in accordance with the conditions in this Permit and the application and supporting information submitted. Where there is a conflict with a condition in this permit and the application and supporting information, the condition in this Permit shall prevail.
- 3.2 The issuance of, and compliance with this Permit, does not:
- a) relieve the Permit Holder or any other person from any obligation to comply with any other applicable legal requirements, including
    - i. the provisions of the Pesticides Act, and any regulations made thereunder;
    - ii. the federal Pest Control Products Act, and the Fisheries Act, and any regulations made thereunder; or
    - iii. any other federal, provincial, or municipal law;

or

  - b) limit in any way any authority of the Ministry, a Director, or a Provincial Officer, including the authority to require certain steps be taken or to require the Permit Holder to furnish any further information related to this Permit.
- 3.3 This Permit authorizes one treatment per treatment location with the pesticide Reward<sup>®</sup> during the specified Treatment Period and is not transferable. The Permit Holder shall ensure treatment is only performed in water fronting properties where the property owner has provided consent. The Permit Holder shall ensure that a copy of this Permit is provided to all participating property owners prior to the commencement of the treatment.
- 3.4 Application of aquatic herbicides, as authorized by this Permit, is only permitted in accordance with any conditions, instructions, or limitations placed on the treatment(s) by Fisheries and Oceans Canada and/or the Ontario Ministry of Natural Resources and Forestry.
- A copy of any Letter of Advice, or any other correspondence related to the extermination authorized by this Permit, containing conditions, instructions or limitations issued by Fisheries and Oceans Canada or Ontario Ministry of Natural Resources and Forestry, shall be provided to Tim Hannah, Regional Pesticides Specialist by email (Tim.Hannah@Ontario.ca) once received by the Permit Holder.
- 3.5 The Permit Holder shall ensure all adjacent landowners, lessees and/or potentially affected parties are notified of the proposed treatment a minimum of 48 hours prior to the commencement of the

treatment. This notification shall include information regarding the treatment date/time and restrictions on water use identified on the pesticide label.

- 3.6 Immediately prior to treatment, the Permit Holder shall ensure that signs/notices are erected which state the treatment date and time; the product being used; and water use restrictions identified on the product label. These signs/notices shall be sufficient to warn the public against using the water for swimming or animal consumption for 24 hours and human consumption or irrigation for five days. The permit holder shall ensure that these signs remain in place until the specified use restriction times have elapsed and that the signs are removed by the sixth day following treatment.
- 3.7 Treatment is authorized within the treatment locations in areas where weed growth is, or is likely to become, sufficient to interfere with the safe operation of watercraft in the boating areas and/or with swimming in the designated swimming areas.
- 3.8 The use of Reward® for aesthetic purposes or for the treatment of emergent aquatic vegetation (i.e., wild rice, cattails, bulrushes, water lilies, etc.) is NOT permitted.
- 3.9 Following treatment with Reward®, the Permit Holder shall take all reasonable measures to ensure that the treated water is not used for swimming and/or animal consumption for 24 hours and human consumption and/or irrigation for five days.
- 3.10 The Permit Holder shall ensure any situations involving health or environmental effects or damage to property related to the treatment(s) authorized by this Permit is reported immediately to the local **Ministry's Peterborough District Office: 1-800-558-0595**; or if a pesticide spill occurs, to the **Spills Action Centre at 1-800-268-6060**.
- 3.11 By November 1, 2023, the Permit Holder shall ensure that a summary report is completed, and a copy of the report submitted to:

- 3.12 This Permit expires on the date that the summary report is submitted.

*The reasons for the imposition of these terms and conditions are as follows:*

Condition 3.1 is included to ensure that the conditions in this Permit are complied with and can be enforced.

Condition 3.2 is included to clarify the legal interpretation of aspects of this Permit.

Conditions 3.3 through 3.9 are included to protect the quality of the natural environment so as to safeguard the ecosystem and protect human health.

Condition 3.10 is included to ensure that the Ministry is immediately informed of the occurrence of an emergency or otherwise abnormal situation so that appropriate steps are taken to address the immediate concerns regarding the protection of public health and minimizing environmental damage and to be able to devise an overall abatement strategy to prevent long term degradation and the re-occurrence of the situation.

Condition 3.11 is included to provide a record for future reference, to ensure that the Ministry is made aware of problems that may have arisen, and to provide a compliance record for all the terms and conditions outlined in this Permit.

Condition 3.12 specifies the expiry date of this Permit.

#### **4. RECONSIDERATION AND APPEALS**

##### **A) REQUEST FOR RECONSIDERATION**

*In accordance with section 13(9) of the Pesticides Act, you or a person authorized under the Law Society Act to represent you may request that this decision be reconsidered by the Director. Your request may be made in writing or orally but the submissions must be made to the Director within 7 days after the date this decision was served on you. The contact information for the Director is set out below.*

*In response to your request for reconsideration, the Director may vary, rescind or confirm this decision. The Director will serve you with a written notice of the decision no later than seven days after receiving the request for reconsideration.*

*If this decision is varied or confirmed by the Director after receiving a request for reconsideration, the Director's notice will include the appropriate instructions for appealing the reconsideration decision to the Ontario Land Tribunal.*

##### **B) APPEAL INFORMATION (REQUEST A HEARING)**

*If you choose not to make submissions requesting a reconsideration of this decision, you may request a hearing by the Ontario Land Tribunal in accordance with paragraph 2 of subsection 13(8.1) of the Pesticides Act. You must serve your written notice of your appeal on the Ontario Land Tribunal and the Director as indicated in the contact information below within 15 days after this decision was served on you. The notice should include:*

1. The name of the appellant;
2. The address of the appellant;
3. The Pesticide Permit number;

4. The date of the Pesticide Permit;
5. The name of the Director;
6. The municipality within which the Pesticide Permit is located;
